- Alcoholic beverage vendors will be assigned areas in the lot around the City of Portola Center Stage or the Portola City Park. Please indicate your preference below. Live music will continue after 8 pm at the City of Portola Center Stage only. You must close at 11PM. Portola City Park will host the Classic Car Show and music throughout the day.
- To the extent possible, we will try to honor your request for location, and limit the number of “like” alcoholic beverage vendors, however preference will be given, “1st come-1st served”.
- Friday & Saturday nights, security patrols will be provided. Vendors are responsible for their own property. Portola Railroad Days Association and the City of Portola will not be responsible for any property loss or damage.
- Please indicate electrical needs on application below.
- RV Camping will be available in designated area only, 1st come-1st served, \$10/Night. No RVs in vending area.
